

A Memorial to be registered
pursuant to the Statute in such case made and
provided, of an Indenture Tripartite made the
Thirtieth day of November in the Year of our
Lord One thousand eight hundred and Sixty, in
pursuance of the Act to facilitate the Conveyance of
Real Property, By and Between Ephraim Hersey
of the Township of Colchester in the County of Essex
and Province of Canada, Yeoman, of the First
Part, Elizabeth Hersey of the same place, Wife
of the said party of the first part of the second
Part, and Susan Jane Hope also of the same place
Widow of the Third Part.

Whereby the said party of
the first part, for and in consideration of the sum
of Ten Dollars of lawful Money of the Province
of Canada, to him in hand paid by the said party
of the third part, the receipt whereof is acknowledged,
Did give, grant, bargain, sell, alien, release,
convey and confirm unto the said party of the third
part her heirs and assigns forever, All that cer-
tain parcel or tract of land and premises, situate
lying and being in the Township of Colchester in
the County of Essex and Province of Canada (apart)
containing by admeasurement Seven Eighths of
an Acre be the same more or less, being composed of
part-

part of the North half of Lot number Eight in the
Fourth of Concession of the said Township of
Colchester, which said Seven Eighteenths of an acre of
land is therein described as follows, That is to say
Commencing at the distance of Six Chains -
(Twelve Links) South from the North East Angle of
said lot number Eight on the limits between said lot
and lot number Nine, Thence South upon said limits
Two Chains eight links more or less to a Stake planted for
a boundary, then West Two Chains eight links more or
less to a Stake planted for a boundary, thence North Two
Chains eight links more or less to a Stake planted for a
boundary, then East Two Chains eight links more or
less to the place of beginning, To have and to hold
unto the said party of the Third Part her heirs and
assigns to and for her and their sole and only use
forever, And by the same Indenture it is witnessed
that the said party of the Second Part, Wife of the
said party of the first part hath thereby barred
her Dowry in the said lands,

Which said Indenture is witness
ed by William Campbell
of the Township of Colchester and
Matthew Matthews of the same place. And
